**ORDINANCE NO. 16-S-2019**

**AN ORDINANCE DECLARING THE FIRST FRIDAY OF SEPTEMBER EVERY YEAR, STARTING SEPTEMBER 6, 2019 AS "PANLALAWIGANG ARAW NG MGA KAWANI NG NUEVA ECIJA"**


**Section 1.** It is hereby declared that the First Friday of September every year, starting September 6, 2019, as "Panlalawigan Araw ng mga Kawani ng Nueva Ecija".

**Section 2.** Application of this Ordinance shall cover all local government units, national government offices, state universities and colleges and GOCCs in the Province of Nueva Ecija and they are hereby enjoined to conduct simple and meaningful activities to celebrate the occasion.


**Section 3.** This ordinance shall take effect upon its approval.


