**ORDINANCE NO. 21-S-2023**

**AN ORDINANCE NAMING THE PROVINCIAL ROAD WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN LEONARDO, AS TAGUMPAY NAGAÑO BOULEVARD (NAGAÑO BOULEVARD), SUBJECT TO THE GUIDELINES OF THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES**

**WHEREAS**, on October 17, 2022, the Sangguniang Panlalawigan received **Resolution No. 36-S'2022**, dated October 17, 2022 from the Sangguniang Bayan of San Leonardo, Nueva Ecija – *A Resolution Requesting the Sangguniang Panlalawigan of Nueva Ecija Thru Vice Governor Anthony “Doc Anthony” M. Umali to pass an Ordinance Naming the Provincial Road within Territorial Jurisdiction of the Municipality of San Leonardo as Tagumpay Nagaño Boulevard (Nagaño Boulevard)*;

**WHEREAS**, the said resolution was referred to Honorable Governor Aurelio M. Umali, for his valuable opinion and stand on the matter;

**WHEREAS**, on February 13, 2023, the Sangguniang Panlalawigan received a communication from the Office of the Governor, respectfully endorsing for due consideration Resolution No. 36-s-2022 seeking the enactment of an Ordinance by the

honorable august body, naming/renaming the Provincial Road in the Municipality of San Leonardo as Tagumpay Nagaño Boulevard (Nagaño Boulevard);

**WHEREAS**, the communication was then referred to the Committee on Laws, Rules and Regulations for further evaluation and study, and for consultation with the National Historical Commission of the Philippines (NHCP), in compliance with Section 13 of R.A. 7160 or the Local Government Code of 1991;

**WHEREAS**, on February 16, 2023, the Sangguniang Panlalawigan required the Sangguniang Bayan to submit documents explaining why the said road should be named after the late Mayor Tagumpay Nagaño, such as his achievements and contributions as a public servant, as well as other relevant documents;

**WHEREAS**, on March 10, 2023, the Sangguniang Bayan submitted a summary of achievements of the late Mayor Tagumpay Nagaño, including copies of barangay ordinances supporting the LGU's project of naming and renaming different streets within the municipality, which justifies the naming of the subject provincial road as vital to the said project;

**WHEREAS**, the Sangguniang Panlalawigan then communicated with the NHCP on March 13, 2023 and March 17, 2023, respectively (thru e-mail), submitting therewith the documents from the Sangguniang Bayan of San Leonardo;

**WHEREAS**, on March 20, 2023, the Sangguniang Panlalawigan received a response from the NHCP which reads, to wit: *"Kindly submit the Sangguniang Panlalawigan Resolution regarding the renaming of a portion of the road and wait for our official reply through a letter signed by our Chair. Only the signed letter from the Chair will be considered as the official consultation and reply to the proposed renaming"*.

**WHEREAS**, the Sangguniang Panlalawigan also sought the technical assistance of the Provincial Engineering Office in identifying the provincial road referred under Resolution No. 36-S'2022 and the latter provided the technical details of portions of the subject provincial road, to wit:

| Road Name                             | Length  | Width | Station Limit        |
|---------------------------------------|---------|-------|----------------------|
| Castellano - San Roque Road           | 4.03 km | 15 m  | Km 95+310 – 99+340   |
| Tambo - Adorable Road                 | 1.20 km | 15 m  | Km 100+360 – 101+560 |
| San Anton - Adorable - Tabuating Road | 6.83 km | 15 m  | Km 100+510 – 107+340 |

**NOW THEREFORE**, under the suspended internal rules and on motion of Board Member Ferdinand V. Dysico, unanimously seconded by the Members present;

**BE IT ORDAINED AND ENACTED BY THE SANGGUNIANG PANLALAWIGAN IN SESSION ASSEMBLED:**

**SECTION 1.** The Provincial Road within the Territorial Jurisdiction of the Municipality of San Leonardo, is hereby named as Tagumpay Nagaño Boulevard (Nagaño Boulevard), subject to the Guidelines of the National Historical Commission of the Philippines.





**SECTION 2.** This ordinance shall be submitted to the National Historical Commission of the Philippines within thirty (30) days after approval.

**SECTION 3.** The Provincial Engineering Office is requested to note and put in its respective record that the provincial road within the territorial jurisdiction of the Municipality of San Leonardo, Nueva Ecija be identified as Tagumpay Nagaño Boulevard (Nagaño Boulevard).

**SECTION 4.** This ordinance shall take effect upon its approval.

Let copy of this ordinance be furnished the Office of the Governor, the Provincial Engineering Office and the Sangguniang Bayan of San Leonardo, Nueva Ecija for their information.
