**ORDINANCE NO. 65-S-2022**

**AN ORDINANCE IMPOSING RENTAL FEES FOR THE USE OF COMBINE HARVESTERS UNDER THE PGNE FARM MECHANIZATION PROGRAM**

**WHEREAS**, on November 29, 2022, the Sangguniang Panlalawigan received a communication from Governor Aurelio M. Umali, respectfully requesting for the enactment of an ordinance imposing rental fees for the use of combine harvesters under the PGNE farm mechanization program. The herein prescribed subsidized rate is computed at 50% of the usual “*hunos*” or share from yield as charged by service providers on a per hectare basis, and will be payable in equivalent value of fresh palay (share rent), as follows:

Particulars	Prevailing Rates under the “Hunos” System	Proposed Rental Fee
1. Rental Fee for the Machinery	10% of yield / hectare	5% of yield / hectare
2. Fuel Cost	Actual consumption	50% of estimated fuel cost, to be computed based on average



consumption of 30 liters  
of diesel / hectare at  
prevailing pump prices

**WHEREAS**, Section 129 of R.A. 7160 or the Local Government Code (LGC) of 1991 provides: Each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy. Such taxes, fees, and charges shall accrue exclusively to the local government units;

**WHEREAS**, Section 153 of the same code also provides that: Local government units may impose and collect such reasonable fees and charges for services rendered;

**WHEREAS**, Section 468 of the LGC likewise states that: (a) The Sangguniang Panlalawigan, as the legislative body of the province, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the province and its inhabitants pursuant to Section 16 of the LGC and in the proper exercise of the corporate powers of the province as provided for under Section 22 of the LGC, and shall: (2) Generate and maximize the use of resources and revenues for the development plans, program objectives and priorities of the province as provided for under Section 18 of the LGC, with particular attention to agro-industrial development and country-wide growth and progress and relative thereto, shall: (ii) Subject to the provisions of Book II of the LGC and applicable laws and upon the majority vote of all the members of the Sangguniang Panlalawigan, enact ordinances levying taxes, fees and charges, prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs;

**WHEREAS**, after careful evaluation, the Sangguniang Panlalawigan finds the request in order and merits approval;

**NOW THEREFORE**, under the suspended internal rules and on motion of Board Member Eric Daniel F. Salazar, unanimously seconded by all Members present;

**BE IT ORDAINED, BY THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**ORDINANCE NO. 65-S-2022**

**AN ORDINANCE IMPOSING RENTAL FEES FOR THE USE OF COMBINE HARVESTERS UNDER THE PGNE FARM MECHANIZATION PROGRAM**

**SECTION 1.** There is hereby imposed rental fees for the use of combine harvesters under the PGNE farm mechanization program. The herein prescribed subsidized rate is computed at 50% of the usual "*hunos*" or share from yield as charged by service providers on a per hectare basis, and will be payable in equivalent value of fresh palay (share rent), as follows:



Particulars	Prevailing Rates under the "Hunos" System	Proposed Rental Fee
1. Rental Fee for the Machinery	10% of yield / hectare	5% of yield / hectare
2. Fuel Cost	Actual consumption	50% of estimated fuel cost, to be computed based on average consumption of 30 liters of diesel / hectare at prevailing pump prices

**SECTION 2.** Any Ordinance or parts thereof, inconsistent with this ordinance is hereby repealed or amended accordingly.

**SECTION 3.** This Ordinance shall take effect upon approval.

Let copies of this ordinance be furnished the Office of the Provincial Governor, the Provincial Treasurer's Office, the Office of the Provincial Agriculturist and the Provincial Food Council, for their information.
